NAMAKAGON GRANT FUNDING

In 2022 the Namakagon Lake Association funded its largest effort yet to treat and control the Invasive Hybrid Milfoil weed. After two years of poor to no results, in 2022 31 beds of hybrid milfoil in 11 areas of the lake were treated in June. After testing different DNR approved chemicals in 2021, 2, 4-D and ProcellaCor were used to treat approximately 32 acres of hybrid milfoil. The cost to treat these areas including, monitoring, testing, permits and consultants came to nearly \$100,000. \$75,000 of this was covered by a 3 year State of Wisconsin Surface Water grant which covered 75% of the cost. The remainder of the cost was covered by volunteer inspections worth approximately \$8,000 and Lake Association funds of \$17,000. Recently we received the reports from the August post treatment monitoring. The report showed a 100% hybrid milfoil elimination in the beds treated! Our hydrologist Matt Berg said these results were exceptional.

The post treatment inspection did show some new individual plants were found near Governor's Island and Jackson Lake and some very small beds in Bluegill Bay. At this time we do not plan to treat the invasive weeds in 2023. The approved lake plan requires the invasive weed beds must be larger than a quarter acre in order to treat. We will monitor the lake to see if these new beds expand and other treated areas show a return of the invasive milfoil weeds. This also means about half of the 3 year grant can be saved if needed in 2024.

Lastly, the official Namakagon Lake Plan must be updated and the Board is looking for additional people to provide input for the Lake Plan. The Lake Plan is a must in order to apply for grants. (We also have a grant that cover 67% of updating the Lake Plan.) The input needed will be gathered in 3, no more than 2 hour meetings at the Namakagon Town Hall. The meetings will be in April, June and July with times and dates TBD. Please contact Larry Pribyl or any Board member if you are willing to give input.

WAKE BOATS, BUOYS, AND VOLUNTEER OPPORTUNITIES

Hi all,

Well we still have 40" of snow on the ground at this writing. All of the Winter sports had great participation and lots of happy visitors and residents. I am told the water content in this snow is very high which could make for high water levels on the lake for long time this Spring. Lets hope the snow melts slow.

A couple things I want to address this Spring are a wake boat update, new buoys on the lake, landing supervision, and other volunteer opportunities.

The Wisconsin DNR has started working on rules for wake boats. Things they are taking into consideration are size of lake, depth of water, and distances from shore that are least destructive to the shoreline. Nothing has been decided and when it is there will be a series of public hearings around the state where all can have their say. I will keep you posted. Until there are set rules as a guideline from the state, we as a lake association will continue to advise everyone using the lake that we do not want to see wake surfing in the narrows by Garmisch and between Junek's Point and Anderson Island. All other areas of the lake please respect our request to stay at least 700 feet away from shore when wake surfing. Thank you.

You will most likely notice some extra buoys out and around the lake this summer. Northland College is doing a study at specific spots on the

LETTER FROM OUR TREASURER

Just recently you should have received your invitation to rejoin, or join, the Namakagon Lake Association. Membership is \$20 for an individual and \$25 for a family. Your donation is tax deductible and will go a long way to offsetting the costs to stock the lake with walleyes, keep invasive weeds in check, and for the general expenses necessary to keep Lake Namakagon one of the top spots to vacation and/or own your home. If we don't invest in the quality of our lake, it will impact tourism, which impacts the livelihood of the restaurants and bars on the lake and more importantly, it could negatively impact the value of your home.

So, please give what you can so we can continue to invest in the future of Lake Namakagon.

NAMAKAGON FISHERIES UPDATE

Data from our comprehensive lake survey is in. We want to thank the many people involved with this project, especially our fisheries biologist, Nate Thomas, for the countless hours associated with analytics and final report. Some of the highlights are as follows:


- Lake Namakagon is classified as a "ceded territory, cool, dark, multi-species lake with natural reproduction. Similar lakes for comparison include Chippewa, Minong, Turtle Flambeau and Butternut.
- Adult Walleye abundance is trending upward and has increased by 87% since 2017 (see chart attached).
- In large part, walleye abundance is highly correlated to recruitment (age 1) which has seen steady increases since 2015 (see chart attached).
- Walleye stocking and habitat improvement also contributes to good recruitment.
- While walleye are the #1 targeted fish across Wisconsin, musky and panfish were the most targeted species on Lake Namakagon based on our 2021 creel survey (see chart attached). Size structure is also greater than the median of comparison lakes.


The DNR/NLA fisheries team is looking to update the Lake Namakagon Management plan based on our recent fisheries survey and user input. 












MISSION STATEMENT
