- <u>Weeds</u>: There are lots of good weeds in the areas treated for Eurasian Milfoil. The treatment work well last year and there is little Eurasian Milfoil in the lake
- <u>Vandalism of Buoys</u>: Several buoys were vandalized. Anyone with information should contact the Sherriff's department.

- <u>Curly Pond Weed:</u> There was a discussion on Curly Pond Weed in the lake. The annual survey and report on the lake will inform us on invasive species in the lake and what should be treated.
