- It was discussed that more hours need to be scheduled at the D and Lakewoods landings for the July 4th week, all week.
- There was discussion on additional means of advertising the lake association to increase membership. Bumper stickers were a past activity. Jim Krueger will contact Advance Printing and put together a sticker for board approval. (Note: Since the meeting, a sticker was presented, and options discussed. Via online discussions, this idea will be tabled for now.)

Open Discussion/Public Comment:

- The milfoil kill was quite successful where it was found and treated. But Sugar Bay is now packed with milfoil. It was not there in the spring survey. Matt is aware of it after a later survey. It is on the list.
- There was a question about a biologist being assigned to our lake. Jim DeRoma will contact Pam Toshner, Water Resources Mgmt Spec-Adv Wisconsin DNR, to follow up.
